a) The bidder should be an Indian Registered Company under Companies Act 1956 or 2013/Proprietorship /Partnership Firm. Copy of Certificate of Incorporation/ Registration/ Partnership Deed or any other relevant document, as applicable, should be submitted along with a copy of address proof.

g) The bidder should not be insolvent, in receivership, bankrupt or being wound up, not have had their business activities suspended and not be the subject of legal proceedings for any of the foregoing. ## 1.7 Form FEES

Form Fee of Rs.1000 (One Thousand rupees) can be paid through electronic mode of payment as per mode available in e-tendering website(*UTR No. is to be provided by bidder in the technical online bid*)

#### Notes for EMD and Tender Fees Exemption:

- a) Micro & Small Enterprises (MSEs) (For goods and services tenders) and Start-up Enterprises are exempted from the payment of EMD & Tender Fees
- b) To avail benefits prescribed in the tender for **Start-up Enterprises**, the bidder shall submit their registration certificate issued by DIPP/DPIIT. Non-submission of requisite proof shall be treated as non-Start-up Enterprise bid.

The bidder should ensure that the Digital Signature used for uploading the tender document in e tenderportal should be of the authorized signatory.

#### 1.10 Contract Signing

Selected bidder will have to sign contract Agreement with BECIL , upon selection recommendation by the competent authority.

#### 1.11 SUBMISSION OF FORGED DOCUMENTS

Bidders should note that BECIL may verify authenticity of all the documents/ certificate/ information submitted by them against the EOI. In case at any stage of this process, if it is established that bidder has submitted forged documents/certificates/information towards fulfillment of any of the EOI/contract conditions, BECIL shall immediately reject the bid of such bidder(s) or cancel/terminate the contract and forfeit bid security / Performance Security submitted by the bidder and debar them from participation in future tenders of BECIL for a period up to 3 years.

### 1.12 CLARIFICATION FROM BIDDERS

The queries may be asked from bidders for submitting shortfall to be submitted within specified date and time. #### SECTION 2. GENERAL TERMS & CONDITIONS OF THE CONTRACT

#### 2.1 Right to accept or reject any or all proposals

- a) Notwithstanding anything contained in this document, BECIL reserves the right to accept or reject any proposal and to annul the Selection Process and reject all proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
- (b) BECIL reserves the right to reject any proposal if:
  - (I) at any time, a material misrepresentation is made or discovered,

Or

(ii) The bidder does not provide, within the time specified by the BECIL, the supplemental information sought by the BECIL for evaluation of the proposal. Misrepresentation/improper response by the bidder may lead to the disqualification of the bidder.

#### 2.2 Conflict of Interest

- a) BECIL requires that bidders provide professional, objective, and impartial advice and at all times and hold the Government Departments/Any Government Organization's Interests paramount, strictly avoiding conflicts with other Assignment/jobs or their own corporate interests and act without any consideration for future work.
- b) Without limitation on the generality of the foregoing, bidders, and any of their affiliates, shall be considered to have a conflict of interest and shall not be engaged, under any of the circumstances set forth below:
  - i. Conflicting activities: A bidder that has been engaged by the Government Departments/Any Government Organization to provide goods, works or assignment/ job other than consulting assignment/ job for a project and any of its affiliates, shall be disqualified from providing consulting assignment/job related to those goods, works or Assignment/job. Conversely, a bidder hired to provide consulting assignment/job for the preparation or implementation of a project and any of its affiliates, shall be disqualified from subsequently providing goods or works or assignment/job other than consulting assignment/job resulting from or directly related to the bidder's consulting assignment/job for such preparation or implementation. For the purpose of this paragraph, assignment/job other than consulting assignment/job a redefined as those leading to a measurable physical output.
  - ii. **Conflicting Assignment/job:** A bidder (including its Personnel and Subcontractors) or any of its affiliates shall not be hired for any Assignment/job that by its nature, may be in conflict with another assignment/job of the bidder to be executed for Government Departments/Any Government Organization.
  - iii. Conflicting relationships: A bidder(including its Personnel and Subcontractors)that has a business or family relationship with a member of the Government Departments/ Any Government Organization's staff who is directly or in directly involved in any part of(i)the preparation of the Scope of Work related to the assignment/ job,(ii)the selection process for the State Date: 2023.07.12 14:07:31 I



assignment/ job, or(iii)supervision of the Contract, may not be awarded a Contract, unless the conflicts terming from this relationship has been resolved in a manner acceptable to the Government Departments/Any Government Organization throughout the selection process and the execution of the Contract.

c) Bidders have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of Government Departments/Any Government Organization, or that may reasonably be perceived as having this effect. Any such disclosure shall be made as per the Standard forms of technical proposal provided herewith. If the bidder fails to disclose said situations and if the Government Departments/ Any Government Organization comes to know about any such situation at any time later, it may lead to the disqualification of the bidder during bidding process or the termination of its Contract during execution of assignment.

### 2.4 RISK PURCHASE

- a) In case, the sub-contractor/ Supplier is not performing its obligations under the contract, the notice shall be sent as per law to the sub-contractor informing that in case of non-performance by a particular date/ period, the contract shall be terminated and the work/ project will be executed (through a third party) at the risk and cost of the said sub-contractor/ supplier as per the terms of the contract.
- b) On completion of the specified period/ date, the notice of termination shall be issued clearly specifying that the remaining work shall be executed (through a third party) at the risk and cost of the sub-contractor/supplier. Along with this notice of termination, intimation shall be sent to the said sub-contractor/ supplier for joint preparation of inventory of the works performed/ supplies already undertaken by him. If the sub-contractor/supplier fails to turn up on an appointed date for joint preparation of inventory, in that situation he shall be proceeded ex parte and the inventory shall be prepared by BECIL/ Employer and the same be sent to the sub-contractor/ supplier.
- c) Further at the time of award of work to another sub-contractor/ Supplier, if the work is awarded at an additional cost than the original sub-contractor/ Supplier, another notice may be issued to the original sub-contractor/ Supplier specifying that the work has been awarded to another agency atthe additional cost of such and such amount, and he is liable to pay that amount to BECIL.

#### 2.5 **ARBITRATION**
