- Bidders should ensure that proposal should complete in all respects. Bidders may visit the site to access all preparatory works/sub system required to execute the works in time bound manner.
- All efforts should be made to procure the items from an Indian OEM (Original Equipment Manufacturer) to avoid exorbitant maintenance expenditure in the future.
- The Bidder shall be solely responsible for the safety, and other statutory regulations in force, with respect to the skilled / non-skilled workers deployed by him for the contracted work and BECIL will in no way liable for any issues related to these.
