Internship Programme

Objective

The objective of 'Internship Programme' is to translate Hon'ble PM's idea of "SABKA SATH, SABKA VIKAAS, SABKA VISHWAAS, SABKA PRAYAAS" for building self-reliant India.

Scope of Activities

Broadly, this programme is meant to help in orienting the students and scholars with the policies and programmes of the BECIL by offering short-term association. The interns may be required to associate with the ongoing projects and other activities of the BECIL.

The scope of activities of the interns will be related to projects such as Strategic Projects (Information Communication Technology, Electronic Surveillance (namely CCTV, Access Control, Intrusion, Fire Safety, Hydrants, etc.), Electronic Media contents including films, Sentinel Analytics, Counter Drones/UAV etc.). The activities include but not limited to Supply, Installation, Testing & Commissioning, Consultancy Services, Technical Audit, Media Analysis, R&D, projects pertaining to Digital India, City Surveillance, Safe City, Smart City, Make in India, Made in India, Manufacturing, Audio Video & Data Analysis, Cyber Security, Engineering, Procurement & Construction, Project Management Services, Operation and Maintenance, Manpower Placement, AMC and providing the total turnkey project for the critical information infrastructure.

Through this Programme, BECIL aims to tap the talent of the interns, giving them opportunity to work for infusing further efficiency in implementation of various projects and other activities being undertaken by BECIL. The Internship Programme would provide a common platform for meaningful interaction of the interns with various external agencies, both government as well as private. At the same time, the interns would also be able to contribute to the ongoing projects and other activities of BECIL.



Salient Features of The Scheme

- ❖ Applicable to 'Indian Nationals' only.
- ❖ The Internship will be available to students engaged in Engineering/ MBA/ Commerce/ Accountancy / Company Secretary/ LLB etc.
- ❖ Duration of Internship will be for the period of two months throughout the year. However, it can be extended subject to the requirement of the reporting officer and availability of the intern. Interns can select any of the two month batches while submitting their applications.
- ❖ A token remuneration@ of Rs.12,000/- (all inclusive) per month, per intern payable on satisfactory completion of their internship and on submission of their Report/Paper.
- ❖ No TA & DA will be given to the Interns, if called for interview and for joining the Internship programme.
- ❖ The Interns will be attached to the concerned officers of BECIL keeping in view the areas of interest expressed by the candidates, their qualification and the preference of that Division.
- ❖ These Interns will be required to present a brief report/paper at the end of their assignment to the concerned Division highlighting their observations and the suggestions, if any.
- ❖ Certificate will be given to the Interns after completing their Internship.
- ❖ The interested students pursuing studies at various Universities and recognized Institutes may send their applications in the **enclosed proforma** alongwith their CVs (optional), at least one month in advance from the date they intend to join.
- ❖ The applications may be sent either by post or by hand addressed to the Ms. Avantika Malhotra, Senior Manager (HR), Broadcast Engineering Consultants India Limited (BECIL), BECIL BHAWAN, C-56/A-17, Sector-62, Noida-201307 (U.P.).
- ❖ All applications will be scrutinized and the actual offer will be sent to the selected candidates subject to the availability of slot and the approval of competent authority. **Maximum number of slots to be offered to these Interns shall not**



exceed three at a time.

- ❖ The selection of Interns would be done by a Selection Committee duly constituted for this purpose. Where necessary, BECIL may also invite certain faculty members/subject experts from universities/reputed research institutes for the selection process.
- ❖ Knowledge of computer softwares, as well as excellent written and oral communication, ability to work in a dynamic environment, good comprehensive skills will be given additional weightage while selecting the Intern.

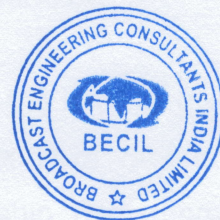
Furnishing of Undertaking/Declaration

- b) The selected intern would furnish a declaration of secrecy before reporting for the internship.

Termination of Internship

BECIL would have the right to appraise/review performance of interns and enforce timely completion of various assignments. It would be desired from the Interns to complete their project activity in time and satisfactorily. In case of non-compliance and non-performance, the BECIL would have right to terminate the internship programme by issuing a notice to concerned intern to this effect.
