The following Addendum is being done in the terms & conditions of the EOI.

5.10 For Consortium / Joint Venture: Allowed

5.10.1 In case of a Consortium/JV, Power of Attorney issued by Board of Directors/ Chairman/CEO / MD / Company Secretary of the Consortium Lead Member as well as Consortium Member(s) of the Consortium/ partners of JV, in favour of the authorised employee(s) of the Consortium /Lead member of JV, for signing the documents on behalf of the Bidder, in respect of this particular tender/ EOI, to sign the Bid and all subsequent communications, agreements, documents etc. pertaining to the tender/ EOI and act and take any and all decisions on behalf of the Consortium/JV, are to be submitted.

5.10.2 The authorized employee(s) of the Bidder shall be signing the Bid and any consequence resulting due to such signing shall be binding on the Bidder.

5.10.3 Bids from consortium/ JV of only two members Including a Leader are acceptable provided that they jointly fulfill the qualification criteria and requirements stated in the Tender/ EOI Documents. Participating Consortium/ JV shall submit the Agreement as per the format attached, clearly defining the roles and responsibility of each member. Members of consortium/ JV shall assume responsibility jointly & severally. The bid security shall be submitted by the Lead Member of the Consortium/ JV. In case of award, the agreement/MOU shall be signed with the lead Member. Further, in case the project is awarded to BECIL, BECIL will accept invoicing and make payment to the Lead Member of the Consortium/JV.

5.10.5 A Consortium/ JV once established at the time of submitting the Bid shall not be allowed to be altered with respect to constituting members of the Consortium/ JV or their

respective roles/ scope of supply/work, except with prior written approval of BECIL. If during the evaluation of bids, a Consortium/ JV propose any alteration/ changes in the orientation

5.10.7 If such bidder is declared L-1, BECIL will sign a Pre-bid Agreement with the Lead member of the Consortium/ JV.
